Registration

Before a child begins attendance, the following requirements must be met:

- Completed SPUMPS Registration form.
- Up to date physical/health record, completed and signed by physician.
- \$250 deposit is due at the time of registration. This deposit will be put towards camp tuition and is non-refundable.

Summer Camp Payments

Summer camp tuition is due every Friday before services are rendered. A late fee of \$15.00 will be assessed for late payments. The agreement to pay tuition is not subject to any adjustments due to illness, vacation, or any other absence(s). We accept cash, check, or Zelle payments for tuition.

Returned Checks

There will be a \$15.00 charge for any check that is returned by the bank for any reason.

Withdrawal

Two weeks written notice is required before withdrawing a child from the school for any reason. If you cannot give this notice, the tuition for the 2 weeks is your responsibility.

Late Charges

It is the parent's responsibility to ensure that their child is picked up at their assigned time. A late fee of \$5.00 for the first five minutes, and \$2.00 for each additional minute, will be assessed for pickup beyond the assigned time. Payment of late fees is expected to be paid in cash to the teacher at the time of pick up.

We will be closed on July 4th.

Absence/Illness

Please call the school if your child will be absent for any reason. You child must be symptom free for 24 hours before returning to school. Please do not bring your child if they are sick with a fever, runny nose, sneezing, coughing or has a symptom of a contagious disease.

Arrivals and Departures

Upon arrival, please park in designated parking spots. Please escort your child into the building and make sure your child's teacher is aware of your arrival. All children are expected to arrive and depart according to their enrollment schedule and be signed in and signed out.

Snacks and Lunches

Parents are responsible for providing their child's snacks for part-time students and lunch for full time students.

Personal Items

All lunches, backpacks and clothing should be clearly labeled with your child's name. Please provide an extra set of clothing for your child in a labeled bag in case of spills, illness, etc.
